Criteria – must meet the following requirements to apply:

- ✓ Provide high school transcript or equivalent if home schooled
- ✓ Provide ACT scores
- ✓ Be enrolled full time at a vocational or tech school, college, or university.
- ✓ Attach typed 500-1000 word essay on following subject: How has Chadron FCU impacted your life?

## Chadron FCU employees, volunteers and their immediate families are not eligible for Chadron FCU's Scholarship.

Funds will be dispersed to the recipients' account as follows:

\*Transcripts may be requested to ensure recipient is in good standing with college.
